Stop Adani ( items 1, 2, 5 & 7)\_

The pressure is on both state and federal governments to stop new coal mines in their tracks. Two important events are being held this week. You will already have received an invitation to join the 'Stop rail line to Adani coal mine' rally at <u>1</u> <u>William Street, Brisbane</u> at 10am (Qld time).

Could you also come along to another event this Tuesday (item #2) outside MP Justine Elliot's office.

Despite we must move away from coal and other fossil fuels to successfully combat climate change, the Australian Labor Party (ALP) is planning a massive expansion of the coal mining industry if they win office.

The justification for new coal mines is economic growth and job creation. However, much of the mining industry is automated and there are no jobs or prosperity on a dead planet. Only 1,494 jobs would be created as a result of the Adani coal mine, with more than 69,000 tourism-related jobs at stake if we allow coal to trash the Great Barrier Reef. There are many more sustainable, ecofriendly jobs in renewables.

If the ALP abandoned its pro-coal policies and fully supported renewables, it would send a strong message to mining companies and investors that there can be no long-term certainty or viability in the coal mining industry. Join <u>Stop Adani Tweed</u> on Tuesday <u>30 January</u> to demand that our Federal Labor MP Justine Elliot influences her party to change their federal policy to 'no new coal mines', and to highlight that their pro-coal mine policies are at odds with their climate action policies.

Tell Justine Elliot that as a voter you don't support a taxpayer funded loan to Aurizon to build a rail line to the Galilee Basin so that Adani and other potential coal mines can transport coal to Abbot Point on the doorstep of the Great Barrier Reef. Tell her that she should pressure the Queensland Government to veto the Aurizon loan, as they did with the proposed \$1 billion loan to Adani to build the rail line.

Show Justine Elliot that Australian voters are strongly <u>against</u> Labor's pro-coal mine policies and that she needs to listen to the people she represents or lose office.
